All your athletes competing in today's meet are in compliance with all National Federation (NF) and Minnesota State High School League rules/regulations regarding being: attired in legal uniforms, using legal equipment, and are not wearing any prohibited jewelry. Undergarments with contrasting stitching are illegal.

2. That you have reviewed the rules and expectations with your athletes and assistant coaches regarding sportsmanship.
3. All athletes understand that i-Pods, cell phones and all other electronic devices are not allowed in competitive or restricted areas. This includes all field event venues, the track, clerk tent, awards area and medical tent. The penalty is disqualification from all events in which the athlete is entered. (NFHS Rule 3-2-4k, Rule 3-2-8)

## Section/State Track and Field Meet Jewelry Rule Warning

**NFHS 2012 Track and Field Rules Book: Rule 4-3-3**

***Jewelry shall not be worn by competitors.***

**PENALTY:** For the first violation, the competitor shall be required to remove the jewelry before further competition, the individual shall receive a warning and a subsequent violation by that athlete shall result in disqualification from the event. The referee shall be notified of the violation by the observing meet official and he/she shall then notify the head coach of the offending athlete of the violation.

**NOTE:** *The ultimate responsibility to have each competitor compliant with uniform and jewelry rules is with the coach.*
